- December 31, 2011      10:00 am - 2:00 pm
- January 28, 2012      10:00 am - 2:00 pm

Tax payments will also be accepted at the Clerk's office during regular business hours from 8:00 - 12:00 and 1:00 - 4:00 Monday thru Thursday.

## Additional Information:

- Taxes will be credited according to postmark.
- Escrow checks must be endorsed and forwarded to the Town. A refund check will be issued to resident if there is an overpayment.
